Export income to Australia from international education activity in 2015


This snapshot highlights the latest data on international education exports released by the Australian Bureau of Statistics in its *International Trade in Services* series^(a).

Size of exports

International education activity^(b) arising from international students studying and living in Australia contributed \$18.8 billion to the economy in 2015. This is a 3.3% increase from the earnings recorded in financial year 2014-15 (\$18.2 billion); up 10.4% on calendar year 2014 (\$17.0 billion) and up 25.3% on calendar year 2013 (\$15.0 billion).

The *total* export income generated by all international education activity was \$19.4 billion. This comprised spending by onshore students (the ABS uses the term 'education-related personal travel' for this item), as well as offshore earnings from other educational services and royalties which generated an additional \$555 million, as outlined in the table below.

Onshore in Australia: Export income from education services




Education-related personal travel is Australia's 3rd largest export after iron ore (\$49.0 billion) and coal (\$37.0 billion). It is the largest *services* export (28% of total services exports), ahead of other personal travel services (\$15.9 billion); and professional and management consulting services (\$5.0 billion).

Education sector^(c)

In 2015, the higher education sector generated \$12.9 billion in export income (68.6% of total on-shore earnings). VET was the second largest, generating \$3.1 billion in earnings (16.4%). Export income from ELICOS was \$1.0 billion (5.4%); schools, \$728 million (3.9%); and non-award, \$698 million (3.7%).
