Export income to Australia from international education activity in 2014-15


This snapshot highlights the latest data on international education exports released by the Australian Bureau of Statistics in its *International Trade in Services* series^(a).

Size of exports

International education activity^(b) arising from international students studying and living in Australia contributed \$18.2 billion to the economy in 2014-15. This is a 14.5% increase from the earnings recorded in financial year 2013-14 (\$15.9 billion^(c)) and up 6.7% on calendar year 2014 (\$17.0 billion).

The *total* export income generated by all international education activity was \$18.8 billion. This comprised spending by onshore students (the ABS uses the term 'education-related personal travel' for this item), as well as offshore earnings from other educational services and royalties which generated an additional \$603 million, as outlined in the table below.


Onshore in Australia: Export income from education services




Education-related personal travel is Australia's 3rd largest export after iron ore (\$54.5 billion) and coal (\$37.9 billion). It is the largest services export (29.0% of total services exports), ahead of other personal travel services (\$14.8 billion); and professional and management consulting services (\$4.7 billion).

Education sector^(d)

In 2014-15, the higher education sector generated \$12.5 billion in export income (68.6% of total on-shore earnings). VET was the second largest, generating \$2.9 billion in earnings (16.0%). Export income from ELICOS was \$1,001 million (5.5%); schools, \$691 million (3.8%); and non-award, \$722 million (4.0%).
