



Data on International Students in Higher Education – Explanatory Note

The Department of Education collects data on international students under the Education Services for Overseas Students Act 2000 (ESOS Act) and the Higher Education Support Act 2003 (HESA). Consequently the department has two data sources relating to international students in the higher education sector. This is a summary of the main similarities and differences. <p>Data are extracted from the Department of Education’s Higher Education Statistics Annual Data Collections.</p> <p>Data are sourced from all Higher Education Institutions that have been approved under the HESA Act.</p> <p>HESA Data are produced by the Higher Education, Research and International (HERI) Cluster of the Department of Education.</p>	<ul style="list-style-type: none"> Enrolments in a higher education award or non-award course with a Commonwealth-funded Australian provider. Onshore (including <u>all</u> ‘temporary resident’ visa types) and offshore campus enrolments, including distance education. Exchange students and Study Abroad students who are liable for tuition fees and non-New Zealand citizens with New Zealand residency. Details on individual providers, course level, 12 fields of study, gender, State and Territory, tuition fees, country of birth, country of permanent home residence, mode of attendance, commencing students, and award course completions. 	<ul style="list-style-type: none"> Enrolments with non Commonwealth-funded providers. Higher doctorate course enrolments. New Zealand citizens. Under HESA, New Zealand <i>citizens</i> are considered to be domestic students. 	<ul style="list-style-type: none"> Data are released in 6 monthly sets: <i>January to June</i> and <i>July to December</i>, about three months after the collection period.
